Sad story #2: This was the 269th mid-engine Corvette produced but an accident left it looking like this. It has extensive damage to the front end and body panel damage on both sides.



### **Museum News-Pat Hillyard**

Even though the NCM Bash took place in a virtual environment, you couldn't stifle the camaraderie and enthusiasm the event produced among the Corvette enthusiasts who attended (virtually).

As part of the event there were two ribbon cutting ceremonies, including a walk through of two galleries and one new exhibit. Those who tuned in to the NCM Michelin Bash stream were able to see the progress that has been made to date on the "Vision Realized" - an exhibit that highlights the many prototypes that led to the creation of the next generation midengine Corvette.

During a presentation about sales of the 2020 Corvette several statistics were given. Top sellers to date: Torch Red is the most popular color at 25%, followed by Arctic White at 15% and Black at 12%. It was also announced that there would be two new colors for 2021. Silver Flare Metallic will replace Blade Silver and Red Mist Tint Coat Metallic will replace Long Beach Red.

Last fall NCRS and NCM announced a collaboration to provide a higher education scholarship. Earning the award was Samuel Amurgis of Columbus, Ohio who plans on attending Ohio State University in the fall and major in Mechanical Engineering.

The Museum opened to the public on June 8th with the normal hours of operation. There are a few changes that have



been made to ensure the health and safety of visitors and staff including acrylic barriers at customer interaction points, hand sanitizer provided throughout the Museum, and social distancing reminders both on the floor, via signage, and PA announcements. They have increased the frequency of cleaning and temporarily limited access to items like the touch screens throughout the Museum. Masks are not required but they have been provided to the staff and there will be some on hand for any visitors that might want one.




