# **Museum News-**




MSP is the first commercialized track in the nation to offer consumer facing driving experiences in the much-anticipated new Z06 Corvette. The Z06 Bundle will allow guests to experience four lead/follow laps on track plus a "Zero to Sixty" launch on the straightaway and a Hot Lap driven by an MSP professional. This add-on is designed to showcase the car's performance capabilities in a fun and safe environment. The Z06's will boast a V7 engine with roughly 670 horsepower and a redline of 8600 rpm that is sure to excite sports car fans. IMPORTANT: Pre-booking is strongly

encouraged, There is limited walk-up availability during the week. Must be 18 years or older and have a valid drivers' license to participate. Participants must sign a Vehicle Damage Policy and Indemnity Agreement. Helmets are provided. Must wear closed toe shoes and long pants. If you cancel 7 days or more in advance of the event date you will receive a 100% refund. Event will run rain or shine.

The 2023 Michelin NCM Bash is scheduled for April 27-29, 2023 in Bowling Green, Kentucky. It will include seminars from Michelin, Mobil 1 Bowling Green Assembly Plant, and classrooms sessions by GM Certified Corvette Technician Paul Koerner. There will be guided road tours, a newly expanded car show, a live auction, and the announcement of the 2023 Corvette Hall of Fame Class. A seminar schedule and more detailed agenda will be made available as details are finalized.

This is a photo from a YouTube video that was posted by "Corvette Nut", who was able to capture some footage of a 2024 Corvette E-Ray Prototype playing in the snow.

Chevrolet first revealed the existence of the E-AWD Corvette in April of 2022 after an interview with GM President Mark Reuss. He shared the news about an electrified Corvette being offered as early as 2023, and a fully electric Ultium-based Corvette coming out sometime in the near future.

This picture of an Accelerate Yellow C8 Corvette recently showed up on social media. It is believed that the car is in Billings, Montana, on top of the rims in the time right before Christmas when the country was in a deep freeze. That's just a guess because other than the frozen stingray, all you can see is snow and blue skies. It's hard to know what the owner was thinking considering the storms that were well forecasted for the area, but Corvette owners do like to be different.



The C8 is still undefeated. In December Car and Driver released the 40th incarnation of the world's most prestigious automotive list and even in its 4th year on the market, the mid-engine Corvette stands tall as one of the greatest vehicles on sale. 2023 marks the 24th time that the Corvette has earned a 10 Best nod, passing the BMW 3series for second place on the all time list. The Stingray and Z06 share a slot on the list.


Ron Thomas had spoken to Vince's wife Shannon and had an update on how Vince's recovery and rehab is going.


